

PSCCU Official Tag Your Watts Contest Rules

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

2. Eligibility. PSCCU (the “Sponsor”) Tag Your Watts Enter-to-Win (the “Contest”) is open to all Washington State residents only, 18 years or older at the time of entry. Employees of PSCCU, and their immediate family members of, and any persons domiciled with such employees, are not eligible. One must share story content and at least one image associated with the #psccuWATTS as a key part of one’s eligibility.

3. Entry. The PSCCU #psccuWATTS social media Contest will begin at 9:00a.m. (P.S.T.) on July 1, 2016 and all entries must be received by 11:00 p.m. (P.S.T.) on the last day of each month as long as the Contest is in action (the “Contest Period”). One must share story content and at least one image associated with the #psccuWATTS as a key part of one’s eligibility.

Only one (1) prize will be awarded to one (1) person/individual.

Applying for and receiving a solar or Energy-Smart loan from PSCCU does not automatically enter one into the Contest.

To enter the Contest without following the above listed Entry process, one must follow the following rules in order to be entered into the Contest:

- Submit an entry request via US Mail or by dropping the entry off at any PSCCU branch location.
- The entry request must have your first and last name, full address, phone number and email address.
- All mailed-in entries must be received by PSCCU no later than 5:00 p.m. PST the last weekday of every month the Contest timeframe is valid.

PSCCU will not be responsible for incomplete, lost, late, misdirected or illegible entries whether originating with sender or Sponsor. In the event of a dispute, all mailed-in entries will be deemed to have been submitted by the owner of the mail piece from which they were sent. Any questions regarding the number of entries submitted or the owner of mailed-in entries shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Contest.

4. Prizes and Odds. One (1) Grand Prize Winner from interactions via PSCCU’s social media conversation associated with #psccuWATTS will be selected in a monthly random drawing from among all eligible entries to be held on or about the first week of every month of the Contest timeframe. Grand Prize: One (1) Grand Prize Winner will receive one (1) \$50.00 VISA Gift Card. Odds of winning depend on the number of eligible entries received.

5. Winner Notification, Acceptance & Prize Delivery. Winners will be notified via a private social media message, by telephone and/or email on or about the first week of each new month during the Contest timeframe. Return of prize notification as undeliverable or no response within 3 business days may result in disqualification and an alternate winner may be selected. Winners may waive their right to receive prizes. Prizes are non-assignable and nontransferable. No substitutions allowed, except that prizes and individual components of prize packages are subject to availability and Sponsor reserves the right to substitute prizes of equal or greater value. Winners are solely responsible for reporting and payment of any taxes on prizes. Winners may be required to complete a W9 tax form, an affidavit of eligibility, and a liability and publicity release (except where prohibited by law) which must be returned within ten (10) days of date of postmark. Failure to sign and return the affidavit or release within ten (10) days, or to comply with any term or condition of these Official Rules, may result in a winner's disqualification, the forfeiture of his or her interest in the prize, and the award of the prize to an alternate winner. Except where prohibited, participation in the Contest constitutes entrant's consent to the publication of his or her name, biographical information and likeness in any media for any commercial or promotional purpose, without limitation or further compensation. For prize winners list (available after January 1, 2017), send a self-addressed, stamped envelope to PSCC, 600 108th AVE NE, Suite 1035, Bellevue, WA 98004, Attn: Marketing & Tag Your Watts. Winners can elect to either have the \$50.00 deposited into a PSCCU account or the \$50.00 VISA Gift Card mailed to them.

6. Participation. By participating, entrants agree to be bound by these Official Rules and the decisions of the judges. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Contest as solely determined by Sponsor. In the event the Contest is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Contest, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Contest. Should the Contest be terminated prior to the stated expiration date, Sponsor reserves the right to award prizes based on the entries received before the termination date.

7. Limitations of Liability. By entering the Contest, entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with the Contest, or any prizes awarded, shall be resolved individually without resort to any form of class action, and entrant waives his or her right to a jury trial for such disputes, claims, and causes of action; (2) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event attorneys' fees; and (3) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.

8. Construction. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any contestant and Sponsor, shall be governed by, and construed in accordance with the laws of the State of Washington, without giving effect to any choice of law or conflict of law rules or provisions (whether of Washington, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Washington. The

invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the valid or enforceable provision was not contained therein.

9. General Release. By entering the Contest, contestants release PSCCU and any other promotional sponsors, and each of their respective affiliated companies, directors, officers, employees, representatives, partners and agents from any liability whatsoever for any claims, costs, injuries, losses or damages of any kind arising out of or in connection with the Contest or with the acceptance, possession or use of any prize (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light).

10. Sponsor. The PSCCU (the "Sponsor") Tag Your Watts Enter-to-Win is sponsored by Puget Sound Credit Union, whose decisions regarding the selection of winners and all other aspects of the Contest shall be final and binding in all respects. Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in other materials relating to the Contest.
